#### **A. GENERAL CONDITIONS**

- In exceptional cases it is possible to accept or deliver a shipment outside working hours, under condition that the customer has prearranged the presence of the Customs.
- In exceptional cases it is possible to accept or Trucks (RFS, IATA Reso 507b) if timely preadvised may be handled outside working hours against additional charges for hiring of manpower as per item 93. of this Cargo Services Price List.
- Consignee or his Agent shall check the condition of shipment on when taking over the goods from the cargo warehouse premises and record any loss and/or damage by Irregularity/Damage Report together with the responsible person of the cargo warehouse. Should fail to do so, it will be considered that the shipment has been delivered in order and in good condition.
- VAT is not included in prices of cargo services.
- Payment can be settled either in cash or cashless transactions. Customers who do not pay their obligations for cargo services within the specified legal deadline, automatically transfer to cash payment.
- For goods placed in a Customs warehouse (Declaration IM J), the storage fee is invoiced on the day of taking over the goods, except for goods that the recipient waived in benefit of the state of BiH.
- Bank commission-fees and other bank charges are borne by the user of Cargo Center services.
- In case of delayed payment, a legal interest rate shall be applied.
- The service of air waybills sale shall be charged in accordance with the valid agreements signed with the air carriers, requirements set in the air carriers' Rate Sheets and in any additional instructions in writing by the air carriers. If the sale of the air waybills is agreed according to NET price of the air carrier, and if it is not specified otherwise in the air carrier's Rate Sheets and in any additional approvals/instructions, then the air carrier's prices shall be increased by a commission fee pursuant to a pricing algorithm as adopted by the Management Board.

**B. INCENTIVE SCHEMES**

1. Reduction of cargo prices will be approved for services are offered to uncommercial organizations and projects, by decision of General Manager of SIA for following:
  - a.) Manipulation and Warehousing services for cargo shipments:
    1. BHDCA i BHANSA, to 100%.
    2. Other institutions at level State of BiH or Federation of BiH, to 100%.
    3. Public health institutions, to 80%.
    4. Cultural institutions and projects at level State of BiH or Federation of BiH of special importance, to 80%.
    5. Sports organizations and events of special importance, to 80%.
    6. Scientific institutions and projects of special importance, to 80%.
    7. Educational institutions and projects of special importance, to 80%.
    8. Provided cargo services for NATO exercises for shipments up to 5 tons, to 100%. Over 5 tons account is done in accordance with the valid Cargo Price List.
    9. Other non-commercial institutions and projects of special importance, to 50%.
  - b.) Services based on humanitarian shipments:
    1. Humanitarian shipments with casualties in natural disasters or other emergency situations, declared to the level State of BiH Federation of BiH, and the user to whom a donation is an international organization or institution at the level State of BiH or Federation of BiH:..... to 100%.
    2. Humanitarian shipments with casualties in natural disasters or other emergency situations, declared to the level State of BiH or Federation BiH, for other users to which the donation:..... to 100%.
    3. Humanitarian consignments on other bases:..... to 100%.
    4. Manipulation services of export donor shipments of institutions at the level State of BiH or Federation BiH, that are processed through the Cargo Center:..... to 100%
    5. Manipulation services of export donor shipments of institutions at the level State of BiH or Federation BiH, that are processed through direct loading from vehicle onto the aircraft:..... to 100%
2. Based upon physical volume of cargo and mail in a previous year, the discount for the services from item 21 of the Pricelist shall be automatically approved to the scheduled air carriers as follows:

*Physical volume of cargo and mail in the previous year (kg)	Discount accomplished in the current year (%)
≥ 200.000	10%
≥ 275.000	15%
≥ 350.000	20%
≥ 425.000	25%
≥ 500.000	30%

\*An incentive based on cargo and mail volume in a previous year shall be approved to the air carriers based upon the statistical data for the previous year, with the possibility to add up the results for the affiliated companies. The term affiliated company means complexed companies that consist of the mother company which directly/indirectly has the ownership share in the affiliated company/companies of the sister company/sister companies of the air carriers, i.e. the company that consists of the dependant companies/airline companies within the same holding group.

3. Discount to 20% for export postal shipments and to 50% for import postal shipments on services from Chapter 11. of the Price list may be approved to public Postal operators. The amount of the discount is determined by the managements of the Sarajevo International Airport on the basis analysis and proposals of the professional departments of the company.

- If the goods are delivered on a exclusivity basis for a period of at least one year, the International Airport "Sarajevo" doo grants a 25% discount on the price referred to in point 02. Transportation of Goods of this Price List.
- For the goods deposited in the Customs Warehouse for more than sixty (60) days, a discount is automatically calculated to the users of cargo services for the services from paragraph 3 of this Pricelist as follows:

Storage period	Discount %
From 60-90 days	20%
From 90-120 days	25%
From 120-190 days	30%
From 190-250 days	35%
From 250-310 days	40%
From 310-365 days	45%
Over 365 days	50%

- Approval of the discount can be made on the basis of a written request from the cargo service user.
