Pursuant to Article 71 of the Law on Tourism of Sarajevo Canton (Official Gazette of Sarajevo Canton, no. 19/16, 31/17, 34/17 and 13/21), Article 30 of the Articles of Incorporation of the Tourism Association of Canton Sarajevo, the Incentive Programme for Tourism and Air Traffic Development in Sarajevo Canton, no. 02-04-34917-9.1/24 of July 4, 2024, in accordance with the Agreement on Implementation of the Incentive Programme for Tourism and Air Traffic Development in Sarajevo Canton, (no. 1264-1/24 of August 1, 2024), the Minutes by the Committee on evaluation of applications (1757-1/24), the President of the Tourism Association of Canton Sarajevo reaches the following

DECISION ON SELECTION OF AIRLINE COMPANIES

Article 1

After the Public Call carried out, the following airline companies are eligible for subsidizing of air traffic in Sarajevo Canton:

- 1. NORWEGIAN AIR AS (NORWEGIAN AIR SHUTLLE ASA & NORWEGIAN AIR **SWEDEN AOC AB),**
- 2. WIZZ AIR HUNGARY LTD,
- 3. LOT POLISH AIRLINES,
- 4. RYANAIR.
- 5. SWISS INTERNATIONAL AIR LINES LTD,
- 6. EUROWINGS AVIATION GMBH,
- 7. SUNEXPRESS AIRLINES,

and a contract is to be concluded with the same.

Article 2

The Decision shall enter into force on the date of its adoption.

Grounds for Decision

The committee for evaluation of applications, after the evaluation of the applications received in relation to the Public Call, stated by the minutes that seven timely applications were received.
