GENERAL CONDITIONS

General conditions defined prices of lease of office space and land, advertising, parking, use of airport premises and VIP treatment, preparation of ID cards, commission from sales of goods, guarding service, manpower, training of personnel, recording services, service of prices and conditions to be met to be granted discounts.

1. PRICES

- 1.1. Prices are quoted in KM (Convertible Mark). Prices do not include VAT (Value Added Tax) which is borne by users of services, except for car parking, internet and cable TV, i.e. the services marked for including VAT.
- 1.2. Prices include overhead costs, phone extension line (within the Airport) and one parking lot. In addition, a parking lot is granted to airlines that have not leased office space.
- 1.3. For the lease of space for installation of self-service vending machines for hot and cold drinks and self-service appliances with confectionery products in the premises at the Airport location, the announcement will be a public call / announcement / tender. The minimum starting price for the purchase of self-service appliances is 25% of the total realized monthly gross revenue, which is determined at the end of the month on the basis of electronic traffic monitoring.
- 1.3.1. "The amount of a commission fee/discount for credit sales of goods to the employees of the Airport Sarajevo, which the business partner approves to the Airport Sarajevo based on effective credit sale agreement, is 3% of the value of the goods sold.
- 1.5. In case of changes market prices, the Airport hold right to change prices and business conditions, of which legal entities that have a contractual relationship will be notified in a timely manner.
- 1.6. Amendments to the Price List in the current year will be made on the basis of the decision of the Management Board, and at the proposal of the director of the sector.

2. PAYMENT

- 2.1. Accounting and settlement of services are made in KM (Convertible Mark), either in cash, by bank transfer or other legal ways of payment.
- 2.2. In case of a changed price during calendar year, user will pay the price being in force on a day the service was provided.

In case of advance payment, the price will be calculated according to the Price-list valid on a day of payment until the advance is spent. If the advance payment is not spent entirely during contracted period when the advance payment was made, the same prices and conditions will be applied in a new contracted period.

- 2.3. For users having head offices out of Bosnia and Herzegovina, services shall be invoiced in EUR, at the mean rate of the Central Bank BiH, valid on a day of invoicing.
- 2.4. Airport keeps the right to require users to obtain payment instrument insurance.
- 2.5. In case of payment delay, default interest will be calculated according to the law.

2.6. In case of cancelling the use of office space-countainer, user is obliged to inform the Airport in written form 24.hrs. before planned use of the office space-countainer. Othervise the Airport will issue an invoice regardless of the fact it was not used.

3. USE OF AIRPORT PREMISES FOR GOVERNMENT-FINANCED INSTITUTIONS

- 3.1. Budget institutions that are of special importance for the functioning of the Airport, such as: Indirect Taxation Authority, Border Police, Intelligence and Security Agency, BHANSA, Sanitary and Veterinary Inspection, are approved to use business premises with overhead costs (heating, water and sewerage, electricity, garbage collection and cleaning). Prices of overheads are regulated by the Price List of Complementary Services.
- 3.2. The Federal Ministry of the Interior Federal Police Administration is granted a 60% discount on the service of renting land for a container and renting land for other purposes.

4. INCENTIVES TO BE GRANTED DISCOUNTS

- 4.1. Lease of one advertising position:
 - 10% discount granted for 1-year-long lease,
 - 15% discount for 2-year-long lease.
- 4.2. Lease of two advertising positions:
 - 6 months, 10% discount,
 - 1 year, 15% discount,
 - 2 years, 20% discount.
- 4.3. Lease of three advertising positions:
 - 6 months, 20%, discount,
 - 1 year, 25% discount,
 - 2 years, 30% discount.

The Company is responsible for printing the advertisments only in case of Agreements signed for a year or longer.

- 4.4. Conditions to be granted a discount on the value of advertising space lease:
- 4.4.1. Lease of advertising position at the price of 500,00 KM 1.000,00 KM:
 - 6 months, 5% discount,
 - 1 year, 10% discount.
- 4.4.2. Lease of advertising position at the price of 1.000,00 KM 2.000,00 KM:
 - 1 year, 15% discount,
 - 2 years, 20% discount
- 4.4.3. Lease of advertising position at the price exceeding 2.000,00 KM:
 - 6 months, 20% discount,
 - 1 year, 25% discount.



- 4.5. The requirements for getting the quantity discount for the offices leased (below mentioned discounts are not applied to the budget beneficiaries and the retail facilities for the lessees for which the calculation of the lease is applied based on the percentage amount of the monthly revenue)
- 4.5.1. Lease of one office for a year, 10% discount
- 4.5.2. Lease of one office for two years, 15% discount
- 4.5.3. Lease of two offices for a year, 15% discount
- 4.5.4. Lease of two offices for at least two years and more, 20% discount
- 4.5.5. Lease of three offices for a year, 20% discount
- 4.5.6. Lease of three offices for at least two years and more, 30% discount
- 4.5.7. Business Lounge, Premium Loounge, VIP Lounge and VIP treatment for children aged 2-12 years: discount 50%
- 4.5.7.1. Business Lounge, Premium Lounge, VIP Lounge and VIP treatment for children aged 0-2 years: free of charge
- 4.5.7.2. The discounts for using the VIP premises are 40% for the representatives of the institutions defined per the operational procedure OPR 05 02 Prihvat i otprema VIP delegacija i putnika (OPR 05 02 Handling of VIP Delegations and Passengers):
 - a) Representatives of the highest level of the government of the country of B&H
 - 1. Chairman and the members of the B&H Presidency,
 - 2. Speaker and the deputy speakers of both chambers of the Parliamentary Assembly of B&H,
 - 3. Chairman, ministers and the deputy ministers in the Council of Ministers of B&H,
 - 4. Other persons when having a status of the state delegation member.

* Use of the VIP premises for the delegation of the Presidency of B&H entails, besides the standard catering, additional catering in the value of 50.00 BAM which shall be included in the price of the VIP premises use.

** The discount in the amount of 40% is granted for the use of the VIP premises by the high-level delegations of the foreign countries, pursuant to the announcement by the Protocol Department of the Presidency of B&H and when the payment for the servicers in question is made by the Presidency of B&H.

*** The discount in the amount of 40% is not granted for the use of the VIP premises by the high-level delegations of the foreign countries and the diplomats accredited in B&H as a resident and a non-resident ambassador, pursuant to the announcement by the Protocol Departments of the defined government levels from this item of the Pricelist, the Presidency being exception.

- 4.5.8. Conditions to be fulfilled in order to be entitled to the discount for busniess lounge:
- 4.5.8.1. Use of the business lounge for airline companies (CIP and Premium) for a period of contract duration of one year minimum or for a period the service is used in duration of at least three months uninterruptedly; the discount is 20%
- 4.5.8.2. Use of the business lounge for other companies (CIP and Premium) and credit card holders for a period of contract duration of one year minimum or for a period the service is used in duration of at least three months uninterruptedly (Priority Pass, Dragon Pass, Dream Folks, Mastercard, TAV etc.); the discount is 30%
- 4.5.9. Lease of office space for airlines and security agencies/bodies related to the realization of flights 50% discount
- 4.5.9.1. Renting a counter per day and per hour for airlines may be realized with a 50% discount
- 4.5.10. Lease of office space for EUFOR, 60% discount
- 4.5.11. Lease of office space for airline representatives, 10% discount
- 4.5.12. Lease of business premises for tourist boards and organizations, discount 60%
- 4.6. Conditions to be granted discount for lease of advertising space per m² based on quantity:
- 4.6.1. Lease of space 1- 5 m², for a year, 10% discount.
- 4.6.2. Lease of space 1- 5 m², for at least two years and more, 15% discount
- 4.6.3. Lease of space 5-10 m², for a year, 20% discount.
- 4.6.4. Lease of space 5-10 m² for two years, 25% discount
- 4.6.5. Lease of space over 10 m², 30% discount, regardless of lease period.
- 4.6.6. Lease of land for installment of advertising structures, 3 or more, discount 15%
- 4.6.7. "The lessees that lease 3 or more positions in part of outdoor advertising are approved with a discount in terms of lower percentage amount of revenue achieved which is in the amount of 25% of the monthly generated revenue from the advertisement content on LED screen; however the price of the monthly lease cannot be less than 1.500,00 BAM."
- 4.7. Conditions to be granted parking dicount depending on quantity:
- 4.7.1. Lease of 3 parking lots, 10% discount.
- 4.7.2. Lease of 4 and 5 parking lots, 15% discount
- 4.7.3. Lease of 6 and more parking lots, 20% discount

- 4.8. Conditions to be granted discount on use of infrastructure and airport services in case of film making:
- 4.8.1. For use of infrastructure and service of the value up to 5.000,00 KM, 10% discount,
- 4.8.2. For use of infrastructure and services of the value from 5.000,00 KM -10.000,00 KM, 20% discount,
- 4.8.3. For value of using the infrastructure and services exceeding 10.000,00 KM, 30% discount,
- 4.8.4. For use of airport space for making student or similar non-commerical movies, under condition of submitting of relevant documentation-evidence, 80% discount.

Note:

Discounts are applicable for strictly defined lease period. In case the contract is terminated before expiry of contracted lease period, the discount shall remain unchanged. Except for the aforementioned, the Company shall not make corrections to already approved discounts defined by item 4 of the Price List of Complementary Services for the lessees that have a concluded Agreement with the Company for the lease of the premises at Sarajevo International Airport and that encounter difficulties in business operations caused by natural disaster declaration or the disaster of any other kind (problems in business caused by spreading of contagious diseases and similar) as well as with the termination of a lease agreement upon a request of the Lessor, not caused by a breach of contractual obligations by the Lessee.

Under the conditions when the lessee delivers a written certificate (evidence of initiating a bankruptcy procedure, liquidation request, etc.) used to prove the uncertainty of his future business due to financial issues for which he temporarily cancels the agreed leases, a no-fault contract termination may be approved without calculating the difference in approved discount

Tenants of business premises who move to a temporary location are granted the right to use discounts approved through the basic lease agreement for the period of use of temporary business premises.

The above-mentioned discounts cannot be combined.

Lessees whose visibility of the leased office space is reduced, due to works that are in the domain of the Lessor, are permitted to display an advertising board-banner or totem until the completion of activities that will restore the visibility of office space to its original state.Sarajevo Airport enables setting up logotypes related to the cultural heritage and promotion of the City of Sarajevo inside/outside of the terminal building that have previously been approved by authorized sectors and after signing a Contract on Business Cooperation.

Lessees whose visibility of the leased office space is reduced, due to works that are in the domain of the Lessor, are permitted to display an advertising board-banner or totem until the completion of activities that will restore the visibility of office space to its original state.

Lessees may set up a stand at the location inside the terminal building, pursuant to the previous approval by the Lessor, for performing promotional activities related to retail/hospitality services provided in the leased business area.

Lessees may set up a stand at the location inside the terminal building, pursuant to the previous approval by the Lessor, for performing promotional activities related to retail/hospitality services provided in the leased business area.

Tenants and business partners with whom the Company has signed contracts for the supply of goods for DFS are authorized to set up a stand at the location inside the terminal building, in accordance with the previous approval by the Lessor, for the purposes of carrying out promotional activities related to the retail/service activities they provide in the leased business premise, they are also given the option to distribute the fliers in the terminal building with a previous approval of the Lessor or another location approved by the Company, as well as the assortment available in DFS, with the possibility of distributing promotional packages to travelers and visitors.

Discounts for leasing business premises are defined under points 4.5.1 – 4.5.6 do not refer to retail and catering facilities.

The Lessees of the retail premises are entitled to broadcast a promotional video content in duration of 12 seconds maximum on the available video walls in the terminal building, in accordance with the available capacities and the positions that the Airport Sarajevo defines

The Company is obligated to make the change of the sign for rent-a-car agencies on the NACO facility only for the first time of making the visual. The lessees shall cover the expenses for any subsequent change, with an approval regarding the layout of the visual previously obtained by the competent department of the Airport Sarajevo.

- 4.9. For airlines promotional flights:
- 4.9.1. For use of VIP lounge,100% discount.
- 4.9.2. For VIP treatment,100% discount.
- 4.9.3. For use of restaurant,100% discount.
- 4.9.4. For use of speaker's stand,100% discount.
- 4.10. For the purpose of exercises (civil and military) being conducted in order to train staff for rendering assistance in emergency situations and international armed forces exercises.
- 4.10.1. For use of VIP lounge, 100% doscount.
- 4.10.2. For VIP passenger treatment, 100% discount.
- 4.10.3. Space for placing the Info desk, 100% discount.
- 4.10.4. Free use of the airport infrastructure is approved for the purpose of reportages which aim to promote the Airport Sarajevo and the services the Airport provides as well as for the purpose of reporting via public
- 4.10.5. The Company's Management Board retains the right to support the projects being of the public interest as well as non-commercial projects and to support the implementation of some services from this Pricelist, partially or entirely, royalty-free, with an obligation of signing the Agreement on business cooperation and/or sponsorship.
- 4.11. The discount the Management Board may approve in case of introducing the new services is 40%, taking into consideration that a period of the promotional discount implementation cannot be longer than six months from the moment of introducing the service in question. *

*Note: A time proposal for the implementation of the abovementioned discount depends upon factors such as a type of service being introduced, expected performances, a profile and

passengers' preferences, an estimated necessary period for the implementation of the promotional discount for the promotion of the service, all in the aim of accomplishing the expected performances and similar. The Management Board, upon a proposal of the Airport Services Department, approves the proposal for the implementation and the length of the discount duration. In case that a period of the discount implementation originally proposed does not achieve the expected results, the Airport Services Department may deliver a proposal for the discount extension to the Management Board, except that a total time interval of the discount duration cannot be longer than six months.

4.12. SEASONAL DISCOUNTS ON THE FIXED AMOUNT OF THE LEASE FOR RETAIL PREMISES IN THE TERMINAL BUILDING, IN THE PERIOD FROM NOVEMBER 1 TO MARCH 31 ARE GRANTED IN THE AMOUNT OF 50% WHERE THE VARIABLE PART OF THE LEASE STAYS UNCHANGED

* The Company Management retains the right to review this discount annually, and to, pursuant to the proposals of the Airport Services Sector and in reference to realized income of lessees and fluctuation of the passenger transport in Sarajevo Airport performs potential corrections in reference to the upper listed discount as well as the validity period.

** When calculating the variable part of the leasing of business premises, the amounts

defined in the Price List of complementary services for each individual business premises are

observed.

- *** Incentive discounts are not applied to tenants of catering facilities.
- **** The tenant of the business premise can use the discount only on one basis, and the discounts

cannot be collected.

4.13. Stimulative discounts of 50% to the fixed amount of the lease for the lessees of the business premises in the terminal building, where the contracted variable amounts remain unchanged. *

*The discounts are valid for a period from 1 April 2025 to 31 October 2025.

5. Other fees:

The fee for performing the activity in the MAS area for persons/legal entities with which the Company is not under a contractual relationship in amount of KM 2,000.00 w/o VAT per recorded

action.

6. Exemptions from charging the service for parking the vehicle in front of the terminal building of Sarajevo Airport upon exercising official duty:

Sarajevo Airport approves parking vehicles in front of the terminal building of Sarajevo Airport (or in

the official parking lot of the New Administrative Building in instance of limited capacities) for the

following institutions exclusively upon exercising official duty 1:

- Ambulance vehicles upon performing official activities,
- Police and security bodies at all levels, including the court police upon performing official activities,
- Firefighting vehicles upon performing official activities."

In instance that the upper mentioned institutions utilize the service of parking vehicles in front of the terminal building outside their official duty, it will be invoiced to them pursuant to the valid Price List for Complementary Services.

3.8. PROFESSIONAL STAFF TRAINING SERVICES

The price of the professional staff training service was calculated in accordance with the Training Programme at Sarajevo International Airport. The price is based on the number of training hours for each specialist course (theory and practical), instructors' gross hourly wages, and coefficients of availability and complexity of individual courses.

The prices are based on the fact that the training takes place at the JP MAS Personnel Training Centre. The price of the staff training service is increased by 100% per candidate for training that takes place outside regular examination periods, if the conditions for holding the training have been created. The price includes:

- Training based on the Professional Training Plan and Programme,
- Training material (applications for exams, notepad, and pen),
- Exam (written, oral and practical part),
- Certificate of completed training.

Price correction:

The price of the service is adjusted in the following cases:

- a) In the case of applying for a tender, a discount on the official prices will be considered by the Administration depending on the type of education and number of candidates.
- b) If there are more than 5 candidates in the group, the price is reduced by 15% per candidate.
- c) If there are more than 10 candidates in the group, the price is reduced by 30% per candidate.
- d) Training held outside the JP MAS Training Centre are increased by travel expenses, per diems and accommodation per day, per instructor.
- e) Validation/recognition of certificates of training, authorisation, certificates of completed specialist course and each subject from the training program acquired in external school centres independent of the Professional Staff Training Centre of the Sarajevo International Airport
 - BAM 70.00 per applicant.
 - If it is established that the candidate needs to additional training classes according to a specific syllabus, additional BAM 40.00 must be paid for each class, per candidate.
- f) Only practical training on demand (equipment handling all types of ground handling equipment)
 - BAM 40.00 per hour of training, per candidate.
- g) Only practical training on demand in the domain of de-icing/anti-icing of aircraft and surfaces

3.9 SERVICES OF AIRPORT STAFF HIRING OUT TO OTHER ECONOMIC OPERATORS

The airport provides worker hiring out services to other economic operators as needed, in the area of JP MAS and outside it. The price is based on the gross hourly rate of the staff being hired out and the level of expertise and responsibilities that each assignment requires. The basic calculation unit is one hour, but in case of engagements that exceed eight hours, the calculation unit becomes one day. Price based on one day is based on the price of eight hours with a reduction of 20%. Airport staff who are engaged for a period exceeding eight hours cannot effectively work more than eight hours within a twenty-four hour period. An economic operator to which the airport staff is temporarily hired out at a location outside JP MAS bears full costs of travel, per diems and accommodation of the hired-out staff.
